➔ **Specifications for Bamboo Fly Rods:****

- Make: Rod is 100% shop-made from raw stock materials.
- Bamboo: Tonkin cane imported from China via broker.
- Reel Seat Type: Sliding band, down locking.
- Cork Handle: Flor grade cork ring stock imported from Portugal.
- Butt Cap: Machined / fabricated from nickel silver stock.
- Sliding Band: Machined / fabricated from nickel silver stock.
- Cork Check: Machined / fabricated from nickel silver stock.
- Winding Check: Machined / fabricated from nickel silver stock.
- Hook Keeper: Fabricated stainless steel wire stock.
- Snake Guides: Fabricated stainless steel wire stock.
- Agate Stripping Guide: Fabricated stainless steel stock; silver bezel; agate slab stone.
- Ferrules: Machined silicon aluminum bronze 642 bar stock.
- Tip Top: Fabricate stainless steel wire stock; machined nickel silver bar stock.

➔ **Client Decisions:****

- Reel Seat Insert: Maker selected hardwood stock or Flor grade cork imported from Portugal.
- Cork Handle Shape: full wells; half wells; cigar
- Silk Wrap Color: main wraps & tipping
- Metal: blued (darkened) or bright
- Bamboo Coloring: blonde or flamed (aesthetic consideration; all bamboo is baked)
- Agate Stone Coloring
- Taper,*** Hollowing,*** Swell***

Other:**

- Includes a protective tube.
- Includes a protective sock.
- Includes 100% shop-made ferrule plug(s).
- Includes shop labels on tube and sock.

➔ Payment:

- Shipping costs and insurance are paid by customer.
- Payment in full (including rod, shipping and insurance) is due prior to shipping.
- No deposit required.

Warranty:

- 100% satisfaction guarantee. If for any reason the customer is not satisfied with the rod, it may return (postage & insurance paid by customer) within three (3) days for a full refund. The rod MUST be un-fished and in its original condition. Any damage resulting from a returned item is not the responsibility of the maker and/or Fly-By-Day, LLC.
- A warranty for defects in workmanship and materials is extended to the original owner of the rod for 3 years.
- This warranty does not cover damage due to abuse, accident, negligence, misuse, exposure to adverse temperature and/or humidity, or normal wear and tear.
- This warranty is entirely limited to repair or replacement of the claimed defect found to be defective by the maker.
- In no event shall the maker, or his heirs or assigns, be liable for any indirect, incidental or consequential damages.
- It is noted that bamboo and other natural natural products used in rods differ in look and characteristics. Such differences, on their face, are not considered defects.
